IDENTIFICATION

- Valid driver's license(s) or state issued picture ID(s) for all applicants
- □ Social security card(s) for all applicants
- □ Valid permanent resident card *if applicable*

INCOME

- Income tax returns for the last two (2) years with
 W-2 forms; if applying with someone else they must also provide their income tax returns for the last two (2) years.
- Self-employed applicants must bring the last two years of filed income tax forms (please ensure Schedule C and 1099 forms are included with your tax forms).
- □ **Last four (4) paystubs** for each employed household member who will be living in the home.
- Other income such as social Security (SSI), retirement, disability, unemployment, nutrition assistance, or other benefits bring award/confirmation letter (all pages) – *if applicable*
- □ **Bank statements** for the last two months for all checking and saving accounts (bring all pages).
- Asset statements for the last two months for all accounts, such as retirement accounts, 401K plans, and IRA (bring all pages).

CHILD SUPPORT

 □ If awarded or required to pay child support provide court order and last 12 months of payment history - *if applicable*

DIVORCED - ALIMONY
